4.SOME BILLS WRITTEN BY DC POLITICIANS AGAINST D.E.W and BIO WEAPONS (Bills can be read at Congress.gov)

NOTE: NONE of these Bills became law to BAN the use of these weapons.

H.R.2977 (2001) – Space Preservation Act Section 7 (excerpts) (2)(ii) Inflicting death or injury on, or damaging or destroying, a person (or the biological life, bodily health, mental health, or physical and economic well-being of a person)--

(II) directed at individual person or targeted populations for the purpose of information war, mood management, or mind control of such persons or populations; or

(C) weapons designed to damage space or natural ecosystems (such as the ionosphere and upper atmosphere) or climate, weather, and tectonic systems with the purpose of inducing damage or destruction upon a target population or region on earth or in space.

*The following bills are also named the Space Preservation Act and NEVER became law to ban these weapons:

H.R.3616 (2002) -9 Dem co-sponsors **H.R.3657** (2003) 4 Dem co-sponsors; **H.R.2420** (2005) – (35) Dem Co- Sponsors

5. Proposed Bills from Democrats to “account for and limit transfer” of military-grade weapons to local and state law enforcement. NONE of these Bills became law and transfer of weapons and NO accountability still continue.

H.R.5478(2014) Section 2 # 7 reports of missing equipment and inappropriate weapons transfers.

H.R.1232 (2015) Section 2 Missing equipment Section 3(1)(f) A-G) 40+ DC Democrat Representatives proposed this Bill to STOP access of “MILITARY GRADE WEAPONS to Federal and state law enforcement.

6. Bills proposed by KY Senator Rand Paul to “Stop Militarizing Law Enforcement Act” to local and state law enforcement to remove access of “military” weapons. NOTE: NONE of these proposed Bills became law - transfer of weapons and no accountability still continue.

Senate Amendment 872 to H.R.2810 (2018) – NOT transfer “some weapons” Section 1702(D)(d)(1 – 10) and return surplus;

S.3931 (06/10/2020) – not transfer some weapons and 100% accountability of weapons

S.1856 (9-25-2017) Section 2 (D)(d1-10) Limit transfer of DOD PERSONAL PROPERTY to Fed & State law enforcement; 100% accountability
